Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depends on the relationship you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and income • Account balances and assets • Transaction history
How?	All financial companies need to share certain personal information of customers and investors to run their everyday business. In the section below, we list the reasons companies can share this personal information; whether Live Oak Private Wealth, LLC chooses to share; and whether you can limit this sharing.

What we do	
How does Live Oak Private Wealth, LLC protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Live Oak Private Wealth, LLC collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> • Open an account • Deposit money • Seek advice about your investments • Enter into an investment advisory contract • Tell us about your investment or retirement portfolio or earnings <p>We also collect your personal information from other companies.</p>
Why can't I limit all sharing?	<p>Federal Law gives you the right to limit only:</p> <ul style="list-style-type: none"> • sharing with affiliates to use for everyday business purposes –information about your creditworthiness • sharing with affiliates to use your information to market to you • sharing with non-affiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>

Definitions	
Affiliates	<p>Companies related by common ownership or control. Affiliates can be financial and non-financial companies.</p> <ul style="list-style-type: none"> • <i>Live Oak Banking Company</i> • <i>Live Oak Bancshares, Inc.</i>
Non-affiliates	<p>Companies not related by common ownership or control. Non-affiliates can be financial or non-financial companies.</p> <ul style="list-style-type: none"> • <i>We do not share with non-affiliates so that they can market to you.</i>
Joint marketing	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>We do not jointly market.</i>
